

SPECIFICATION AND RULES

- A 3-minute gate call will be enforced.
- A \$50.00 fee will be charged for all returned checks.
- Unjudged rounds are limited to the end of a class if time permits.
- All equitation divisions will be judged on hands, seat, guidance and control. Tests may be at the judge's discretion.
- There will be six ribbons in all classes.
- Champion and reserve ribbons awarded in each division.
- Proof of negative coggins test within 12 months required!!!!
- Stalls are available on a limited basis, only if reserved in advanced.
- Appropriate schooling show attire is required.
- Hard hats must be worn at all times while mounted.
- No boots/bandages or artificial equipment in hunter classes.
- Judges decisions are final!!
- No Smoking on Grounds
- No Dogs Allowed.
